





VCSE Brokerage Framework – Information and Guidance for the Communities against Cancer programme

Published date:	6 th November 2024
Deadline for clarification questions:	28 th November 2024, midday
Deadline for proposals:	18 th December 2024 - 5pm

This document includes information and guidance for VCSE organisations to make proposals to deliver activities to address the desired aims, impact and outcomes of the Communities against Cancer programme.

Funding has been made available from NHS England through the Somerset, Wiltshire, Avon and Gloucestershire Cancer Alliance (SWAG) to BNSSG ICB Cancer Team, who are looking for a host organisation to deliver this programme of work.

Hosted and led by one VCSE organisation and delivered in local communities this programme has specific aims:

- to help raise awareness and understanding of possible signs and symptoms of cancer, encouraging the public to see their GP to help improve early diagnosis (which in turn improves patient outcomes).
- to encourage people to participate in or attend cancer screening.
- to help the public understand how to reduce their risk(s) of developing cancer through lifestyle choices.

The opportunity for Voluntary, Community and Social Enterprise (VCSE) organisations to make proposals to meet the aims, impact and outcomes, set out later in this document, is provided by the BNSSG VCSE Brokerage Framework. We are inviting proposals from VCSE organisations that have either been accepted onto the VCSE Brokerage Framework (with or without conditions) or have an application in process¹.

The VCSE Brokerage Framework is a new system-wide approach to enable a diverse range of VCSE organisations to deliver health and wellbeing improvements in local communities, through investment from Integrated Care System (ICS) health and social care partners. The Framework provides a standard, robust and inclusive process for assessing the best proposals for community activities. This approach (which includes this investment opportunity) is being co-designed and tested during 2024, with an anticipated full launch in 2025. We are interested in your feedback on this process – please see Your Feedback (below).

Things to note when developing your proposal

- All parts (the blue boxes) of the proposal form should be completed.
- Word limits maximum word limits are included. We encourage organisations making proposals to be proportionate and use the number of words needed to answer the

questions. Please don't feel that you need to reach the maximum word count, if you can respond with fewer words. Additional words over the limit will not be considered.

- Proposals can be for new or continuation of existing activities. We acknowledge that, for new activities, a longer implementation/set-up time may be needed.
- Explanations and guidance are shown in *italics* throughout the proposal form.
- For help when completing the proposal, you should attend the Engagement Event/s and/or note the deadline for clarification questions (see Timeline below).
- Partnerships and collaborations in this period, while we co-design and test this new
 way of working, we are inviting individual organisations to make proposals. If your
 proposal specifically includes other partners, please include explanation about your
 relationship (for example, contract or memorandum of understanding), how the work
 may be allocated between partners, and any budgetary implications².
- Budget proposal please refer to the guidance notes in the Budget Template and make sure all parts (the blue boxes) of the template are completed. Your completed budget template should be submitted with your completed proposal form.

About the Communities against Cancer programme

The target in the NHS Long Term Plan (LTP) is that by 2028, the proportion of cancers diagnosed at stages 1 and 2 will rise from around half now to three-quarters of cancer patients. (NHS Long Term Plan v1.2 August 2019) In part, this needs to be achieved 'from the ground up' by encouraging better understanding of signs and symptoms so that the public present to their GP in a timely manner, as well as increasing participation in national cancer screening programmes and adopting healthier lifestyle choices.

The Communities against Cancer programme will help raise understanding and awareness of cancer signs and symptoms, to help improve early diagnosis and to encourage people to attend cancer screening in our area. It will also convey messages about 'reducing your risk' through healthier lifestyle choice.

Community organisations are a trusted voice and can play an important role in providing information within local communities to increase symptom awareness, reduce risks of cancer and support to those who may face concerns or practical barriers to taking up cancer screening.

This programme is expected to focus on people living in the most socio-economically deprived areas, across Bristol, North Somerset and South Gloucestershire (BNSSG) as evidence shows that they are 20% more likely to have their cancer diagnosed at a late stage and face almost 25% more emergency admissions in the last year of life compared to people in the least deprived areas. However, the Inner City and East Bristol Locality already has a separately funded project and is therefore not included within the remit of this investment opportunity.

The Communities against Cancer programme requires a host VCSE organisation to take a lead role; employing a project manager who will encourage 'understanding and reducing cancer

risk' conversations, and deliver cancer awareness training to other organisations and community groups.

The host VCSE organisation will also hold a budget and work closely with, and allocate funding to, a wide range of smaller and specialist VCSE organisations across BNSSG for initiatives that encourage or support improving early diagnosis and might also:

- Reduce health inequalities in their local community
- Contribute to creating healthier lifestyles

If your organisation is interested in being part of the programme, but do not feel they are right for the host role, please submit an Expression of Interest to the Brokerage Team via proposal@bnssgvcsealliance.org who will then pass details onto the lead organisation once they are appointed.

This opportunity is to support communities to design and implement their own solutions to improve the earlier diagnosis of cancer, increase screening uptake and convey healthy lifestyle choices to reduce cancer risk.

What may be funded?

This funding aims to:

- Improve early diagnosis of cancer.
- Reduce health inequalities in BNSSG.
- Contribute to creating healthier lifestyles.
- Deliver education/training, to organisations/groups in face to face or online sessions; and staff and venue costs can be included.
- Support the development of local, relevant information resources identified through needs assessment for a specific group or community.

Reasonable overhead costs can be included in proposals.







What cannot be funded?

This funding is not for large capital spends or anything that does not support direct provision.

Inner City and East Bristol Locality already has a separately funded project and is therefore not included within the remit of this investment opportunity.

Which organisations can make proposals?

Proposals must be from VCSE organisations based and/or working in Bristol, North Somerset, or South Gloucestershire and that have either been accepted onto the VCSE Brokerage Framework (with or without conditions) or have an application in process.

We especially welcome proposals from small / micro VCSE organisations that have built strong, trusting relationships within their local communities.

If you are yet to submit an application to join the Brokerage Framework we cannot guarantee your application will be reviewed and confirmed prior to the proposal due to the required timeframe for the quality assurance process. However, you are still encouraged to submit an application and the Brokerage Team will endeavour to process it in time.

Outcomes and impact

All VCSE organisations that deliver funded projects/activities will be asked to collect some outcome measurements, to help us understand their impact. The outcome measurements for the Communities against Cancer programme are:

- Improved community confidence about understanding the symptoms of cancer.
- Improvement in people within communities knowing who to contact if they are concerned about a possible symptom of cancer.
- Improved community understanding of how to reduce the possible risks of cancer and the importance of screening.
- A reduced concern within BNSSG communities around speaking with a medical professional about a possible cancer concern.
- Improved understanding within communities around how to reduce the risk of cancer through healthy lifestyle choices

These programme outcomes are linked to the following Healthier Together System Outcomes:

 We will increase population healthy life expectancy across BNSSG and narrow the gap between different population groups (POP1)







- We will reduce early deaths from preventable causes in the communities which currently have the poorest outcomes (POP2)
- We will increase the proportion of people who report that they are able to find information about health and care services easily (SERV7)

There will be a standard requirement for all VCSE organisations to coordinate and provide diversity data of the participants/beneficiaries of funded activities.

How proposals will be evaluated and scored

The proposal form includes a standard set of questions that are given weightings (as shown in the proposal form) and feed into the following evaluation themes.

Evaluation themes	Weighting
Ability to serve the community	5%
Improving access and reducing health inequalities	25%
Integration, collaboration and connections	25%
Quality, improvement and innovation	25%
Economic and financial standing	5%
Realistic costing and value for money	5%
Social Value ³	10%

These evaluation themes are based on the Provider Selection Regime³ and the ICB's Standing Financial Instructions, including the Grants and Contracts Standard Operating Procedures.

Evaluation of the proposals for each health programme/investment will be facilitated by the Brokerage Team and a specific Evaluation Panel will be chaired by the programme manager/majority budget-holder and will comprise ICS and VCSE experts related to the specific programme/investment in question. Declaration of interest processes will be followed.

All evaluated questions will be scored on a scale of 0 to 4, as follows.

Evaluation panel members will score independently and, after all scores are collated by the VCSE Brokerage Team, the Evaluation Panel will meet to discuss and moderate scores. Any outstanding Quality Assurance conditions or notable points will also be considered by the panel.

Depending on the programme, the panel will discuss the range of awardable proposals, how they meet the overall programme aims/impact/outcomes and note potential award conditions. Award recommendations will be based on (moderated) scores, diversity and portfolio of activities and reach. Following due diligence⁴,, the programme manager/majority budget-holder will coordinate the process of finalising grant agreements or contracts, as well as communication and implementation.

Financial information

Total fund:	£225,000.
Source of funds:	Somerset, Wiltshire, Avon and Gloucestershire Cancer
	Alliance (SWAG).
Duration of funding:	Two years.
Anticipated start date:	April 2025.

It is anticipated that a significant proportion of the total funding will be allocated to smaller/specialist VCSE partners that have reach into excluded communities. Proposals will need to describe the approach to identifying and establishing effective collaboration with such organisations. Arrangements should be clearly defined (for example, with contracts or agreements), describe how VCSE partners will be supported and enabled to deliver, have fair and transparent financial arrangements (for example, full-cost recovery and payment in advance) and describe how delivery will be monitored etc.

It is anticipated that the investments for the Communities against Cancer programme will be made through a contract.

The contract will be finalised as soon as possible after due diligence and clarifications have been completed. Terms and conditions, including the payment schedule and reporting requirements, will be included in the contract agreement. As this programme welcomes proposals from smaller organisations, and we know that cash flow can sometimes be challenging, the intention is that an element of the awarded grant will be transferred up front when the contract agreement is finalised.

Feedback will be offered to all organisations that make proposals. Such feedback may include overall scores, comparisons with other scores, moderation overview and qualitative feedback.
