## Dear Sir/Madam

We are undertaking research into the way in which NHS ophthalmology care, in particular cataract surgery is commissioned by Integrated Care Boards (ICBs) from the independent sector.

We are seeking to understand the extent to which services are commissioned from the independent sector through direct contracts with ICBs or whether they are provided on a non-contract activity basis.

We are also seeking to understand whether optometrists are permitted to make direct referrals to NHS providers (both in the NHS and the independent sector) and if so when this approach was introduced.

As a result, I am asking you to provide the following information under the Freedom of Information Act 2000:
