Please refer to requesters template enclosed.	The ICB has applied Section 43(2) to financial information contained in the service specification, GP Care – DVT Pathway. Section 43(2) exempts from disclosure information which would, or would be likely to, prejudice the commercial interests of any legal person (an individual, a company, the public authority itself, or any other legal entity). Section 43(2) is a qualified exemption and therefore subject to the public interest test. The public interest argument in favour of disclosing the information include the ICB's responsibility to be transparent and accountable in it's decision making processes and to promote public understanding of processes. The public interest argument in favour of maintaining the exemption includes the ICB's responsibility to secure the best use of public resources and provide value for money. There are robust procurement processes in place to ensure that the NHS commissions services which are value for money and competitive.
