			The ICB has applied Section 40 (Personal Information) to the request for email addresses and has exempted this information from disclosure.									
			The ICB considers email addresses to be personal information and when considering the disclosure of personal information, the ICB must consider whether disclosure would contravene any of the data protection principles. The ICB needs to determine whether the disclosure would be lawful, fair and transparent.									
			Below are the six factors the ICB must consider when determining whether disclosure of the information is lawful: <ul style="list-style-type: none">• Is the data special category data?• Is the information criminal offence data?

- Is there any Article 6 lawful basis for processing the personal data?
- Does lawful basis (a) – consent - apply?
- Does lawful basis (f) – legitimate interests – apply?

The ICB has determined that the requested data is not special category data neither is it criminal offence data.

The ICB must therefore consider whether the lawful basis (a) or (f) would be relevant to disclosure under the FOI Act for this case.

The ICB considers that there is a legitimate interest for the request therefore exemption under lawful basis (f) has not been applied.

For the lawful basis (a) - consent to be satisfied for disclosure, the individuals must provide their consent for their personal information to be disclosed as part of the response. The ICB has contacted the individuals who have not consented for their email addresses to be disclosed. Under the FOI Act, this does not mean that the email addresses are automatically exempt from disclosure, however consent is an important consideration for the ICB.

In determining whether no consent outweighs the public interest in the information, the ICB has considered whether other routes of contact are available to the public, whether the disclosed information would allow contact to be made with the correct individuals and the

	<p>impact on disclosure of the information when consent has not been given.</p> <p>The ICB has considered whether disclosure of the email addresses is necessary to fulfil the request. The ICB has established that there are other routes of contact for PCNs which are available on webpages specific to GP Practices or for the PCNs themselves. These outline the established routes of contact for PCNs. The ICB has disclosed the information it holds regarding the names of Clinical Directors and Business Managers for the local PCNs, therefore anyone wishing to contact these individuals is able to address their communications to them directly.</p> <p>The ICB has considered that the impact of sharing email addresses without consent may be detrimental to the ICB's relationship with the local PCNs and ultimately General Practices. It is in the public interest for the ICB to work collaboratively with local GP practices and PCNs in order to commission and deliver high quality primary medical care services for the local population. This may be at risk if the ICB publishes personal information where consent is not expressly provided.</p>
