ReSPECT Plus (ReSPECT and Advance Care Plan)

Bristol, North Somerset and South Gloucestershire (BNSSG) ICB have implemented a new digital solution for sharing Recommended Summary Plans for Emergency Care and Treatment (ReSPECT) and advance care planning to help coordination of care for those with a serious or life limiting illness or frailty. This shared care plan is called ReSPECT Plus and it is hosted on the Black Pear Shared Care Planning System. A summary of the information is printed off the system and given to the patient. This contains exactly the same information and headings as a purple national ReSPECT form but looks different. This patient held document is known as the 'BNSSG ReSPECT form.'

The Black Pear Shared Care Planning System has been deployed to community users in BNSSG ICB over the last twelve months. ReSPECT and practical advance care planning information can be added directly to the ReSPECT Plus record in the Black Pear system and this contains much more information than the existing EMIS GP templates which are seen in ReSPECT/End of Life views in the GP records tab in Connecting Care. Code mapping has been set up to continue saving a limited amount of ReSPECT Plus information (e.g. CPR decision) in the existing GP records views in Connecting Care.

From July 2023, all data captured in ReSPECT Plus in Black Pear has been sent to Connecting Care, and this is now visible in the document view. Only the latest version of each ReSPECT Plus record will be visible in document view. If you have access to the Black Pear Shared Care Planning System this will give a full history of the changes made to the ReSPECT Plus record and not just the last person that updated the record. Please note that printing the ReSPECT Plus document from Connecting Care for the patient is not recommended, as the BNSSG ReSPECT form printed from the Black Pear PDF is the only locally approved patient held ReSPECT form

1. ReSPECT/End of Life Alert

On the **patient banner** you will see the **alert for the known ReSPECT/End of Life Record**. If a ReSPECT/End of Life Record has been shared the alert will be coloured red.



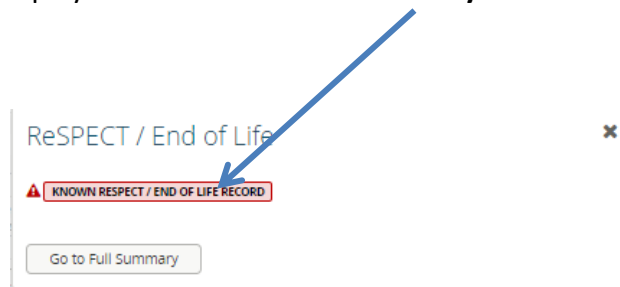
There are three options for this alert:

- **‘ReSPECT/Known End of Life Record’** - this indicates the patient has a ReSPECT/End of Life Record in the EMIS GP system or ReSPECT Plus in the Black Pear Shared Care Planning System and will display in red.
- **‘ReSPECT/No Known End of Life Record’** - this indicates the patient **does not** have an EOL Record in EMIS GP system or a ReSPECT Plus Black Pear Shared Care Planning System and will display in blue.
- **‘Unable to Load ReSPECT/End of Life Record’** - this indicates the patient has not consented to sharing their information with Connecting Care or there is a problem loading the record due to a technical issue. This will display in orange.

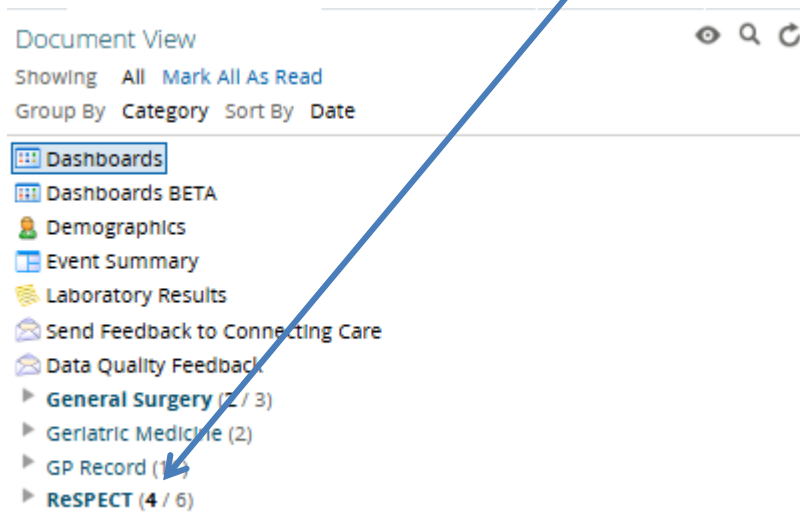
Click on the alert and then select **‘more’**



The alert pop up will display. Click on **‘Go to Full Summary’**



This will take you to the **'Person Summary'** from which the Blackpear ReSPECT Plus information can be found under ReSPECT.

2. Documents

i. Document Panel

The document panel initially displays the last 10 documents that have been received relating to the patient being viewed. If Connecting Care has received a ReSPECT Plus form from Black Pear there could be an entry in the Document panel. Selecting this will open the ReSPECT Summary View (Recommended Summary Plan for Emergency Care and Treatment-BNSSG)

Viewing Updates to ReSPECT/End of Life Information

***Note:** Any updates made in Black Pear Shared Care Planning System will be shown in Connecting Care as two new entries in the document list under ReSPECT and will not overwrite any previous documents received..*

For example, if the patient changes their decision on the location for preferred place of death and care and this has been recorded in Respect Plus this will display as a separate entry for each. **The latest documents will appear at the top of the list.**
