The above time taken, plus the time to individually review each request, extract the data, and compile at ICB level would significantly exceed the time limit under the FOI act and therefore cannot be provided. We do not currently see a way to bring this request in under the 18-hour time limit as the request is seeking to cover such a broad range of data.

(e) the increase of the existing floor area of premises used for providing primary medical services which would lead to an increase of a payment made to the contractor under these Directions; or

(f) premises improvements, which are to be the subject of a premises improvement grant application, and it puts that proposal to NHS England as part of an application for financial assistance in respect of the proposal, NHS England must consider that application."

 Please provide me with as much direction as you can within the cost limits as to where I can find the information requested above for the years prior to the Bristol, North Somerset and South Gloucestershire ICB taking commissioning duties. BNSSG ICB (previously CCG) only took on primary care contracting responsibilities from NHS England from 2019/20 onwards.
