A significant number are carried out through independent providers under Right to Choose, which are also funded by the ICB. However, despite significant increased levels of investment in ADHD services, and increased investment in ASD assessment services, demand continues to exceed service availability. As such, the service models are not sufficient to meet local need. To respond to this the ICB has</p>

	prioritised the redesign of services to respond to increased demand in a sustainable way.
